

It is hereby notified that tenders are invited for the **Provision of Telecommunication Services for Various Locations of the Social Welfare Department for a period of 24 months (Tender Reference: SWDT032023)**.

Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.

A tender in triplicate must be placed and sealed in two separate envelopes. The 'Technical Proposal' must be placed and sealed in one envelope while the 'Price Proposal' must be placed and sealed in another envelope.

Tenders must be clearly marked with the tender reference, the subject of the tender and the tender closing date on the outside of the envelopes (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Tender Opening Committee, Government Logistics Department, and be deposited in the Government Logistics Department Tender Box located on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon (Hong Kong time) on 16 October 2023 (Monday). Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

In case tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the tender closing date, the tender closing time will be postponed to 12.00 noon (Hong Kong time) on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.
