

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

ROAD IMPROVEMENT WORKS AT MA ON SHAN, SHA TIN

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, planters, amenity areas, traffic islands, bus stops, slope, cycling tracks and cycle parking place within the limit of works area as shown on Plan No. ST49/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 6486 published on 18 November 2016 and 25 November 2016. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 23 September 2022 to 22 September 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, planters, amenity areas, traffic islands, bus stops, slope, cycling tracks and cycle parking place to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve realignment of a section of the existing Hang Tai Road and Sai Sha Road, construction of a slip road connecting the existing Hang Tai Road to the existing Ma On Shan Road (northbound), widening of a section of the existing Ma On Shan Road (southbound), modification of the existing junction at Hang Shun Street/Hang Tak Street/A Kung Kok Street and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, planters, amenity areas, traffic islands, bus stops, slope, cycling tracks and cycle parking place on 9 September 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
