- (ii) (For Electronic Tendering) Transmission of the tender through the e-Tender Box shall be successfully completed in accordance with the requirements of the e-Tender Box before the tender closing time.
- (iii) Late tenders or tenders not submitted in accordance with any one of the submission methods specified in (i) or (ii) above will not be accepted.
- (iv) In case Tropical Cyclone Warning Signal No. 8 or above is hoisted, or Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force, for any duration between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone
