TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing footpaths, cycle track, amenity area and beach within the limit of works area as shown on Plan No. HWDIS101A-GZ0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8699 published on 23 November 2018 and 30 November 2018. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 30 September 2023 to 29 September 2024, all public or private rights in, upon, under or over the sections of the existing footpaths, cycle track, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a footbridge of approximately 35 metres (m) long across Wang Tong River, a cycle bridge of approximately 35m long across Wang Tong River and pedestrian crossings, as well as other ancillary works.
