

**ELECTORAL AFFAIRS COMMISSION (NOMINATIONS ADVISORY
COMMITTEES (DISTRICT COUNCILS)) REGULATION
(Cap. 541E)**

Pursuant to sections 2(2), 2(3), 2(4), 3(3), 3(4), 5(2), 5(3) and 6(2) of the Electoral Affairs Commission (Nominations Advisory Committees (District Councils)) Regulation (“the Regulation”), the following notices are given —

I. Appointment of Nominations Advisory Committees (District Councils)

The following legal practitioners are each appointed as a Nominations Advisory Committee (District Councils) (“NAC(DC)”) for the period from 15 September 2023 to 1 November 2023 (both days inclusive) in relation to the District Council Ordinary Election to be held on 10 December 2023 with the nomination period from 17 October 2023 to 30 October 2023 —

II. Periods in which each NAC(DC) must perform its functions

Each NAC(DC) is to perform during the following periods its functions specified under section 3(1) of the Regulation —

- (a) Between 15 September 2023 and 20 October 2023, to perform its functions on applications by prospective candidates to seek advice and to complete the same by 20 October 2023.
- (b) Between 17 October 2023 and 1 November 2023, to perform its functions on applications by Returning Officers to seek advice and to complete the same by 1 November 2023.

III. Periods in which applications for advice from the NAC(DC) are to be made

- (a) Applications under paragraph II(a) above must be made in the specified form and lodged with the Chief Electoral Officer either in person, by post or by facsimile transmission, so as to be received by that Officer between 15 September 2023 and 16 October 2023 (both days inclusive).
- (b) Applications under paragraph II(b) above must be in writing and lodged with the Chief Electoral Officer, so as to be received by that Officer between 17 October 2023 and 31 October 2023 (both days inclusive).

The specified form mentioned under paragraph III(a) above may be obtained free of charge during business hours on any day from 15 September 2023 to 16 October 2023 (both days inclusive and other than a general holiday) from the District Offices or at the offices of the Registration and Electoral Office at 8th Floor, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon, or Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon, or can be downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>).
