(Notice under section 8(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL))

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. 91753/GAZ/CNP/3013 and Resumption Plan No. STM9194c (the 'Plans') and described in the scheme annexed thereto, which Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) construction of about 600 metres of twin rising mains and associated manholes within the limit of works area as shown on the Plans;
- (ii) construction of about 1.9 kilometres of gravity sewers and associated manholes within the limit of works area as shown on the Plans;
- (iii) construction of sewage pumping station at Chek Nai Ping village within the limit of works area as shown on the Plans; and
- (iv) ancillary works including reinstatement of carriageways, footpaths and open spaces.
