

## FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

(Notice of authorization under section 9)

PUBLIC WORKS PROGRAMME ITEM NO. 5061TF  
IMPROVEMENT WORKS AT LAI CHI WO PIER

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 3011 published under section 5 on 17 and 24 June 2022 was authorized under section 7 on 16 September 2022.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

## SCHEDULE

*Foreshore and sea-bed affected*

Approximately 1.53 hectares of foreshore and sea-bed situated in Lai Chi Wo as delineated and shown edged red on a plan, numbered DNM4176, deposited in the Land Registry.

*Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking*

Works include construction of a new Lai Chi Wo Pier and provision of a temporary pier during the construction stage. The proposed new pier will be laid over the existing pier. It will be composed of a deck founded on piles, a gangway and a floating platform held in position by piles, covering an area of approximately 1 505 square metres above the sea.

## Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes.
