ROAD WORKS ANCILLARY TO PWP ITEM NO. 4166CD
DRAINAGE IMPROVEMENT WORKS AT YUEN LONG—
SHAN HA TSUEN, LIN FA TEI AND SUNG SHAN NEW VILLAGE*Amendments under section 7*

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to amend the works and the use originally shown on Plans Nos. ACL-4166CD-P-GZP0000, ACL-4166CD-P-GZP1000, ACL-4166CD-P-GZP1001, ACL-4166CD-P-GZP1100, ACL-4166CD-P-GZP1101 and ACL-4166CD-P-GZP1200 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 1458 published under section 8(2) of the Ordinance on 19 March 2021 and 26 March 2021. The proposed amendments are shown on Amendment Plans Nos. ACL-4166CD-P-GZP0000A and ACL-4166CD-P-GZP1001A ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:—

- (i) revision of the originally proposed limit of works area;
- (ii) construction of vehicular crossing and pedestrian crossing;
- (iii) permanent closure and conversion of sections of the existing access roads into pedestrian crossing;
- (iv) temporary closure and reconstruction of sections of the existing access roads and a section of the existing pedestrian crossing;
- (v) temporary closure of sections of the existing carriageways, footpaths, access roads, vehicular crossings and pedestrian crossings;
- (vi) deletion of the originally proposed temporary closure and reconstruction of sections of the existing access roads and a section of the existing vehicular crossing and pedestrian crossing;
- (vii) revision of the area of land proposed to be resumed in respect of the following:—

- (viii) revision of the resumption/clearance limit as shown on Resumption Plan No. YLM10537a (Sheet 1 to 3) ("the Resumption Plan") annexed hereto; and
- (ix) revision of the originally proposed ancillary works, including earthworks and drainage works.

Any person who wishes to object to the proposed amendments is required to address to the Secretary for Transport and Housing an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed amendments in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 29th day of March 2022.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
