  - (b) reinstate the parts of the building, if any, so affected by the building works under items (i) & (ii) above in accordance with plans approved by the Building Authority.

Adequate precautionary measures to prevent damage to the integrity of the parent structure including the damp proofing construction, if any, should be provided during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within <u>30</u> days and complete such works within <u>60</u> days of the date of this order, all to the satisfaction of the Building Authority.


