Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. <u>C/TC/000794/14/NT</u> dated <u>24 April 2014</u> is also empowered to make this order which substitutes the previous order.




