

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS M512—Construction of Quarry Park in Anderson Road Quarry (Programme No. 478RO)**.

The works include the construction of Quarry Park in Anderson Road Quarry comprising a central lawn and landscaped garden, a walking/jogging track with fitness stations, a bicycle park and a bicycle kiosk, an amphitheatre, a viewing platform, an adventurous playground, a pet garden, an orienteering course, two multi-purpose outdoor courts for basketball/volleyball, two futsal cum handball pitches, a light refreshment kiosk, installations with artistic/architectural features and other ancillary facilities, together with associated building services installation, drainage and external works. The site area is approximately 64 220 square metres. The contract is scheduled to commence in September 2023 and for completion in January 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 10 March 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 10 March 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 10 March 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
