

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

STAGE 5B AND REMAINING INFRASTRUCTURE WORKS

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways, at grade footpaths, central medians/traffic islands and amenity areas within the limit of works area as shown on Plan No. 60102100/GAZ/S5/1.6 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8324 published on 2 November 2018 and 9 November 2018. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 17 October 2022 to 16 April 2023, all public or private rights in, upon, under or over the sections of the existing at grade carriageways, at grade footpaths, central medians/traffic islands and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a subway with associated covered staircase, covered escalator and lifts; construction of a landscaped elevated walkway with associated covered staircase and lifts and construction of at grade footpaths, as well as other ancillary works.

This notice will be affixed on or near the affected at grade carriageways, at grade footpaths, central medians/traffic islands and amenity areas on 7 October 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
