(Notice of Authorization under section 9)

OUTLYING ISLANDS SEWERAGE STAGE 2 (PART)
UPGRADING OF TAI O SEWAGE TREATMENT AND DISPOSAL FACILITIES

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 3535 published under section 5 on 8 and 15 July 2022 was authorized under section 7 on 29 September 2022.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 1.34 hectare of foreshore and sea-bed situated in Tai O as delineated and shown edged red on a plan, numbered ISM3364a, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Filling of the sea-bed to form land of approximately 0.26 hectares for the expansion and upgrading of Tai O Sewage Treatment Works;
- (ii) Laying of a submarine outfall of approximately 130 metres long from the shore by dredging method; and
- (iii) Construction of a vertical seawall of approximately 50 metres long, which will function as berthing facility, and a sloping seawall of approximately 100 metres long by non-dredging method.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
