## **Explanatory Note**

These Rules amend the definitions of *closure time* and *judicial officer* in the Court Proceedings (Electronic Technology) (District Court Civil Proceedings) Rules (Cap. 638 sub. leg. C) (*Cap. 638 C*).

- 2. Cap. 638C provides for the treatment of a document sent, or a payment made, to the District Court by means of an e-system (i.e. a designated information system) in respect of a civil proceeding where the document or payment is received during the relevant court office's closure time (as defined by rule 2 of Cap. 638C) that is not a time during which the office is open for the proceeding to which the document or payment relates. Rule 3 amends the definition of *closure time* in that rule 2 so that the closure time of a court office also includes any time during which the office is directed under Order 64, rule 1 or 2 of the Rules of the District Court (Cap. 336 sub. leg. H) to be closed.
- 3. Rule 3 also amends the definition of *judicial officer* in that rule 2.
