Explanatory Note Paragraph 1

Explanatory Note

These Rules amend the definition of *closure time* in, and Schedule 1 to, the Court Proceedings (Electronic Technology) (Magistrates' Court) Rules (Cap. 638 sub. leg. B) (*Cap. 638B*).

- 2. Cap. 638B provides for the treatment of a document sent, or a payment made, to the Magistrates' Court by means of an e-system (i.e. a designated information system) in respect of a relevant proceeding where the document or payment is received during the relevant court office's closure time (as defined by rule 2 of Cap. 638B) that is not a time during which the office is open for the proceeding. Rule 3 amends the definition of *closure time* in that rule 2 so that the closure time of a court office of the Court also includes any time during which the office is directed by the Chief Justice or the Chief Magistrate to be closed to the public.
- 3. The proceedings to which Cap. 638B applies include a proceeding in the Magistrates' Court in relation to which a penalty notice is issued under an enactment specified in Schedule 1 to Cap. 638B and for which the use of electronic technology has been implemented. Rule 4 expands the scope of application of Cap. 638B by adding certain enactments to that Schedule.
