

AVIATION SECURITY ORDINANCE

DESIGNATION OF RESTRICTED AREA NOTICE (NO. 6 OF 2023)

(Made under section 35 of the Aviation Security Ordinance (Chapter 494))

By virtue of the authority under section 35(1) of the Aviation Security Ordinance, Chapter 494, delegated to me by the Aviation Security Authority under section 25(1) of the said Ordinance, I hereby designate the areas described below to be restricted areas:—

- (a) The areas coloured green in the plans numbered ASO/RA/001AJ, ASO/RA/002N, ASO/RA/003J, ASO/RA/004N, ASO/RA/005Q, ASO/RA/006R, ASO/RA/007O, ASO/RA/008R, ASO/RA/009H, ASO/RA/010C, ASO/RA/011A, ASO/RA/012C, ASO/RA/013A and ASO/RA/014A.
- (b) The areas coloured yellow in the plans numbered TRA/AMC/001A, TRA/AMC/002A, TRA/AMC/003A and TRA/AMC/004A.
- (c) The area coloured orange in the plan numbered TRA/GFS/001A.
- (d) The area coloured yellow in the plan numbered TRA/HAECO/001D.
- (e) The area coloured red in the plan numbered TRA/GSEL/001C.
- (f) The areas coloured purple in the plans numbered TRA/AAT/001K, TRA/AAT/002, TRA/AAT/003, TRA/AAT/004B and TRA/AAT/005.
- (g) The areas coloured pink in the plans numbered TRA/Hactl/001, TRA/Hactl/002B, TRA/Hactl/003C, TRA/Hactl/004, TRA/Hactl/005, TRA/Hactl/006, TRA/Hactl/007 and TRA/Hactl/008E.
- (h) The area coloured blue in the plan numbered TRA/AFSC/001B.
- (i) The areas coloured yellow in the plans numbered TRA/BAC/001H and TRA/BAC/002.
- (j) The area coloured yellow in the plan numbered TRA/DHL/001D.
- (k) The area coloured yellow in the plan numbered TRA/CASL/001A.
- (l) The areas coloured yellow in the plans numbered TRA/CPSL/001B, TRA/CPSL/002, TRA/CPSL/003, TRA/CPSL/004, TRA/CPSL/005, TRA/CPSL/006 and TRA/CPSL/007.

The plans have been signed by the Director-General of Civil Aviation and are kept by the Airport Authority. In addition, the plans listed in (b) to (l) are kept by the respective airport tenants indicated on the plans.

The designation made in this notice shall come into operation and supersede the designation made in the Designation of Restricted Area Notice (No. 5 of 2023) (G.N. 5642 of 2023) on 17 October 2023.
