ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths, part of an existing central median/traffic island, as well as the existing pedestrian crossings, within the limit of works area as shown on Plan No. KZ826 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1632 published on 13 February 2015 and 18 February 2015. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 30 October 2022 to 29 October 2023, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths, part of an existing central median/traffic island, as well as the existing pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of lay-by and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, central median/traffic island and pedestrian crossings on 21 October 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
