

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1607EM21T, Triennial Term Contract for Maintenance of Air-conditioning and Electrical Installations at Ruttonjee Hospital, Tung Wah Eastern Hospital and Cheshire Home Chung Hom Kok**. The scope of the Works includes repair and maintenance to the air-conditioning and electrical installations at Ruttonjee Hospital, Tung Wah Eastern Hospital and Cheshire Home Chung Hom Kok. The Contract is scheduled to commence in March 2023 for expiry in February 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5/F., Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 9 December 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 9 December 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 9 December 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
