Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Tenders deposited in the Specified Tender Box at or after the tender closing time, or tenders not deposited in the Specified Tender Box, will not be considered.

If a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force, or Tropical Cyclone Warning Signal No. 8 or above is hoisted at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on the tender closing date as stated above, the tender closing time will be extended to 12.00 noon (Hong Kong Time) on the next working day.
