

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2023/16, Site Formation and Infrastructure Works at Tin Wah Road, Lau Fau Shan (Public Works Programme Item No. B847/CL)**. The works mainly comprise:—

1. site formation works of about 2.0 hectares at Tin Wah Road, Lau Fau Shan;
2. realigning and widening of an existing un-named road (commonly known as New Sha Kong Wai Road) to single two-lane carriageway;
3. widening of a section of Tin Wah Road to dual two-lane carriageway;
4. construction of noise barriers on this section of Tin Wah Road; and
5. other infrastructure works including drainage, sewerage, waterworks and landscaping.

The works are scheduled to commence in March 2024 and will take about 46 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 22 December 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 22 December 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 22 December 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category, who also meet the following qualifications and other conditions for participation stipulated below are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least one construction contract involving roads and drainage works with adjusted contract sum not less than HK\$183 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted contract sum shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 24 November 2023 to Project Team Leader/Project, Civil Engineering and Development Department at Units 01, 05–09 of 35/F One Kowloon, 1 Wang Yuen Street, Kowloon Bay, Hong Kong, meet the qualifications and conditions for participation, and the

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
