Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

- 2. You are required to commence the works ordered by me in paragraph 1 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.
- 3. For the said building works in paragraph 1 above:
  - (a) As a result of items (i) & (ii), Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened.


