

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, elevated footpaths, cycle tracks, central reserves/refuge islands and verges within the limit of works area as shown on Plans Nos. 60336159/GAZ1/100, 60336159/GAZ1/101, 60336159/GAZ1/102, 60336159/GAZ1/103, 60336159/GAZ1/104 and 60336159/GAZ1/105 ('the Plans') and described in the scheme annexed thereto, and as modified by Modification Plans Nos. 60336159/GAZ1/101A (INSET A) and 60336159/GAZ1/104A (INSET A) ('the Modification Plans'). The Plans and scheme were referred to in G.N. 1641 published on 24 March 2016 and 1 April 2016. The Modification Plans were referred to in G.N. 6620 published on 25 November 2016 and 2 December 2016. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 17 November 2023 to 16 November 2024, all public or private rights in, upon, under or over the sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, elevated footpaths, cycle tracks, central reserves/refuge islands and verges to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the widening of a section of Kam Ho Road between Kam Tin Road and Tung Wui Road, widening of a section of eastbound Kam Tin Road between Ko Po Tsuen and Kam Ho Road, provision of bus laybys along Kam Sheung Road, construction of sewer along Tung Wui Road, Kam Ho Road and Kam Tai Road, road junction improvement works in the vicinity and ancillary works.

This notice will be affixed on or near the affected at grade carriageways, elevated carriageways, at grade footpaths, elevated footpaths, cycle tracks, central reserves/refuge islands and verges on 10 November 2023.

Any person having a compensatable interest under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following

means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
