## Notes :

- This statement is prepared on the cash basis of accounting. It consolidates the statements of assets and liabilities of the General Revenue Account and the following eight Funds: Capital Works Reserve Fund, Capital Investment Fund, Civil Service Pension Reserve Fund, Disaster Relief Fund, Innovation and Technology Fund, Land Fund, Loan Fund and Lotteries Fund. It excludes the Bond Fund, the balance of which is not part of the fiscal reserves.
- The assets do not include the investments and loans totalling HK\$845,933 million in the Capital Investment Fund and the loans of HK\$36,033 million in the Loan Fund.
- The liabilities do not include the Green Bonds (equivalent to HK\$166,566 million as at 30 September 2023) issued under the Government Green Bond Programme. They were denominated in US dollars (US\$9,750 million with maturity from May 2024 to January 2053), euros (4,500 million euros with maturity from January 2025 to November 2041), Renminbi (RMB30,000 million with maturity from November 2024 to June 2033) and HK dollars (HK\$20,800 million with maturity from February 2024 to May 2025) respectively for the purposes of the Capital Works Reserve Fund under section 3(1) of the Loans Ordinance (Cap. 61). During the financial year up to 30 September 2023, there were payments of interest of HK\$1,351 million on the Green Bonds but no repayment of principal.

4. The consolidated fund balance includes HK\$307,545 million being the balance of the Land Fund held in the name of Future Fund, for long term investments up to 31 December 2030. The Future Fund also includes HK\$4,800 million, being one-third of the actual surplus in 2015-16 as top up. In June 2020, in a bid to uphold Hong Kong's status as an international aviation hub, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to allocate HK\$27.3 billion of the Future Fund to invest in Cathay Pacific Airways Limited. On 12 August 2020, HK\$19.5 billion was paid for the subscription of preference shares with detachable warrants. The fund required for the investment in Cathay Pacific Airways Limited was drawn from the investments with the Exchange Fund, and remains as a part of the Future Fund. The bridge loan facility of HK\$7.8 billion expired on 8 June 2023 and no drawdown was made throughout the availability period. Cathay Pacific Airways Limited paid the deferred dividend of about HK\$1.5 billion on the preference shares held by the Government on 30 June 2023, bringing its deferred dividend payments up to date.

The Financial Secretary announced in the 2020-21 Budget Speech that part of the Future Fund will be used to establish the Hong Kong Growth Portfolio (HKGP) to make strategic investments in projects with a Hong Kong nexus. The HKGP initially targets at a size of 10% of the Future Fund. In the 2022-23 Budget Speech, the Financial Secretary announced that the funding allocated to the HKGP under the Future Fund will be increased by HK\$10 billion for allocating HK\$5 billion to the Greater Bay Area Investment Fund and the Strategic Tech Fund respectively. The funds required for the investments of the HKGP are drawn from the investments with the Exchange Fund. The Chief Executive announced in the 2022 Policy Address that the Hong Kong Investment Corporation Limited will consolidate the management of the investment activities of the HKGP and the Co-Investment Fund, a new HK\$30 billion fund for which the funds would come from the Future Fund.

- In June 2020, in a bid to uphold Hong Kong's status as an international aviation hub, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to allocate HK\$27.3 billion of the Future Fund to invest in Cathay Pacific Airways Limited. On 12 August 2020, HK\$19.5 billion was paid for the subscription of preference shares with detachable warrants. The fund required for the investment in Cathay Pacific Airways Limited was drawn from the investments with the Exchange Fund, and remains as a part of the Future Fund. The bridge loan facility of HK\$7.8 billion expired on 8 June 2023 and no drawdown was made throughout the availability period. Cathay Pacific Airways Limited paid the deferred dividend of about HK\$1.5 billion on the preference shares held by the Government on 30 June 2023, bringing its deferred dividend payments up to date.

The Financial Secretary announced in the 2020-21 Budget Speech that part of the Future Fund will be used to establish the Hong Kong Growth Portfolio (HKGP) to make strategic investments in projects with a Hong Kong nexus. The HKGP initially targets at a size of 10% of the Future Fund. In the 2022-23 Budget Speech, the Financial Secretary announced that the funding allocated to the HKGP under the Future Fund will be increased by HK\$10 billion for allocating HK\$5 billion to the Greater Bay Area Investment Fund and the Strategic Tech Fund respectively. The funds required for the investments of the HKGP are drawn from the investments with the Exchange Fund. The Chief Executive announced in the 2022 Policy Address that the Hong Kong Investment Corporation Limited will consolidate the management of the investment activities of the HKGP and the Co-Investment Fund, a new HK\$30 billion fund for which the funds would come from the Future Fund.
