

It is hereby notified that tenders are invited for the **provision of services for elderly persons ('the Services') in a new contract home located at Ground Floor (Portion), 2nd Floor (Portion), 3rd Floor (Portion) and 4th Floor (Portion), Social Service Building, Fu Tip Estate, 11 Chung Nga Road, Tai Po, New Territories ('Premises of Fu Tip Estate')**. The Services include providing a maximum number of 100 residential care places in the Premises of Fu Tip Estate (Tender Reference: SWD1/5AN/872/2021).

Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender. A tender must be placed and sealed in two separate envelopes. The 'Offer to be Bound', the 'Non-collusive Tendering Certificate', the 'Technical Proposal' and the 'Financial Information Submission' must be placed and sealed in one envelope while the 'Volume Proposal' must be placed and sealed in another envelope.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelopes (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and be deposited in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon (Hong Kong time) on 24 December 2021 (Friday). Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be considered.

In case tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the tender closing date, the tender closing time will be extended to 12.00 noon (Hong Kong time) on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. session are only allowed to nominate not more than TWO representatives. The Department reserves all rights to reject the attendance of site visit and/or briefing session of any person who is not an eligible potential tenderer and will not entertain onsite enrollment.

In case tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time during the two hours prior to the start of the site visit, the site visit will be postponed. The site visit will be rescheduled and enrolled participants will be informed of the new arrangement in due course.

In case tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time during the two hours prior to the start of briefing session, the briefing session will be postponed. The briefing session will be rescheduled and enrolled participants will be informed of the new arrangement in due course.

This tender is NOT covered by the Agreement on Government Procurement of the World Trade Organization.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the tender with the highest score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
