

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

PWP ITEM NO. 6461TH  
CENTRAL KOWLOON ROUTE

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under sections 17(1)(a) and 17(1)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, central reserves/refuge islands, amenity areas and open space; and to reclaim temporarily the Government foreshore and/or sea-bed within the limit of works area as shown on Plans Nos. 287786/GAZ/1000 to 287786/GAZ/1012 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 287786/GAZ/1000A, 287786/GAZ/1002A, 287786/GAZ/1003A, 287786/GAZ/1011A and 287786/GAZ/1012A ('the Amendment Plans') and described in the amendment scheme annexed thereto, and as further amended by Second Amendment Plans Nos. 287786/GAZ/1034, 287786/GAZ/1035 and 287786/GAZ/1036 ('the Second Amendment Plans') and described in the second amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 6472 published on 1 November 2013 and 8 November 2013. The Amendment Plans and amendment scheme were referred to in G.N. 2448 published on 27 March 2015 and 2 April 2015. The Second Amendment Plans and second amendment scheme were referred to in G.N. 1869 published on 15 March 2019 and 22 March 2019. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 27 November 2022 to 26 November 2023, all public or private rights in, upon, under or over the sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, central reserves/refuge islands, amenity areas and open space to be temporarily closed and the Government foreshore and/or sea-bed to be temporarily reclaimed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a dual three-lane trunk road connecting the Yau Ma Tei Interchange and the road networks on the proposed Kai Tak Development and Kowloon Bay, construction of approach roads connecting to the proposed tunnel portals, construction of slip roads connecting the proposed tunnel with the Yau Ma Tei Interchange as well as the proposed Kai Tak Development and Kowloon Bay, construction of a footbridge across Kai Fuk Road, modification and realignment of a section of Hoi Wang Road, Lin Cheung Road, Kai Fuk Road, Kai Cheung Road and Gascoigne Road Flyover, modification and realignment of a section of the access road to petrol filling stations in Kai Fuk Road eastbound, modification of the Kowloon City Ferry Pier Public Transport Interchange, construction of sections of at grade footpath along Kai Fuk Road, construction of lay-bys along the proposed slip roads E, F and G at Yau Ma Tei, construction of sections of amenity area along the proposed roads and proposed road tunnel building area at Kai Tak Development, as well as other ancillary works.

The works to be carried out in association with this reclamation involve temporary protection and precautionary works on existing seawall, as well as phased temporary reclamation of Government foreshore and/or sea-bed at Kowloon Bay with removal of the temporary protection and precautionary facilities on seawall, as well as removal of the phased temporary reclamation and reinstatement of Government foreshore and/or sea-bed at Kowloon Bay if needed.
