WHEREAS the Building Authority acting in accordance with the powers conferred upon him by section 27A of the Buildings Ordinance has served on the owner of the above-mentioned lot an order in writing dated the 21st day of February 2014 declaring the natural, formed or man-made land and the earth retaining structure on the above lot liable to become dangerous and requiring such owner to carry out the works within the time limit specified therein

AND WHEREAS the said order has not been complied with

AND WHEREAS the Building Authority acting in accordance with the powers conferred upon him by section 27A(3) of the said Ordinance has caused the said works to be carried out from the 11th day of November 2019 to the 18th day of May 2020 by the Government Consultant/Contractor.

AND WHEREAS the cost of the said works and surcharge are in my opinion recoverable from the owner of the said lot

AND WHEREAS it appears from Land Registry records that the above-mentioned lot was as at the date of completion of the said works owned by the Owner of Lot No. 1590 in D.D. 11, Tai Po, New Territories

AND WHEREAS the owner of the said lot was advised of the said works in writing on the 1st day of December 2020

NOW THEREFORE in accordance with the provisions of section 33(1) of the Buildings Ordinance I HEREBY CERTIFY that the cost of the works so caused by the Building Authority to be carried out and surcharge as aforesaid amounts to Hong Kong Dollars One Million Five Hundred and Three Thousand One Hundred Ninety-seven and Sixty Cents only (HK\$1,503,197.60) and that the said Owner of Lot No. 1590 in D.D. 11, Tai Po, New Territories is liable for that sum
