

It is hereby notified that sealed tenders in three sets of hard copies are invited for the **Grant of Licence to Operate Catering Business at the Disciplined Services Sports and Recreation Club of Security Bureau for a period of 60 months from 12 July 2024 to 11 July 2029 (Tender Reference: SB-T02/2023)**.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Government Logistics Department and deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon (Hong Kong Time) on 5 January 2024 (Friday). Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Tenders deposited in the Specified Tender Box at or after the tender closing time, or tenders not deposited in the Specified Tender Box, will not be considered.

If a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force, or Tropical Cyclone Warning Signal No. 8 or above is hoisted at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on the tender closing date as stated above, the tender closing time will be extended to 12.00 noon (Hong Kong Time) on the next working day.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made *via* press releases on the website of Information Services Department (<https://www.info.gov.hk/gia/general/today.htm>).

This tender is NOT covered by the Agreement on Government Procurement of the World Trade Organization.
