

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 15/WSD/20—Term Contract for Maintenance and Operation Support of On-site Chlorine Generation Plants (Phase 2) of Water Supplies Department (2022–2026)**. The works include the inspection, preventive maintenance, corrective maintenance, emergency maintenance, overhaul, testing, operation support, and related works and services for the on-site chlorine generation plants of Water Supplies Department. The works are scheduled to commence in April 2022 for completion in April 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 21 January 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 21 January 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 21 January 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Supply and Installation of Water Treatment Plant' or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Supply and Installation of Water Treatment Plant' who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Supply and Installation of Water Treatment Plant' may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 20 December 2021 to Chief Electrical and Mechanical Engineer/Projects, Water Supplies Department, Sha Tin Office, 6th floor, Sha Tin Government Offices, No. 1 Sheung Wo Che Road, Sha Tin, New Territories, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
