

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING  
DEVELOPMENT AT TIN WAH ROAD, LAU FAU SHAN (ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. 60667622/GZ3/101 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of carriageways, a carriageway with on-street parking space, footpaths, a cycle track, central medians/traffic islands, an amenity area, a staircase, run-ins/run-outs, pedestrian crossings, a vertical noise barrier and a cantilever noise barrier;
- (ii) permanent closure and conversion of sections of the existing carriageways into footpaths, central medians/traffic islands, amenity area and pedestrian crossings;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways, cycle track, amenity area and run-ins/run-outs;
- (iv) permanent closure and conversion of sections of the existing cycle tracks into carriageways, footpaths and run-in/run-out;
- (v) permanent closure and conversion of sections of the existing central medians/traffic islands into carriageways and pedestrian crossing;
- (vi) permanent closure and conversion of sections of the existing amenity areas into carriageways, footpaths, central medians/traffic islands, run-ins/run-outs and pedestrian crossing;
- (vii) permanent closure and conversion of sections of the existing run-ins/run-outs into carriageways and central median/traffic island;
- (viii) temporary closure and modification of sections of the existing carriageways, footpaths, cycle track, central medians/traffic islands and run-ins/run-outs;
- (ix) demolition of a section of the existing vertical noise barrier; and
- (x) ancillary works including site formation, landscaping, drainage, sewerage, water, public lighting and utility works, geotechnical works including slope stabilization works, construction of retaining walls and slopes, as well as installation of street furniture and traffic aids.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 26th day of January 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Logistics Bureau at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
