1. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-

- (a) demolish the building works described under items (i) to (iv) below; and
- (b) reinstate the parts of the building so affected by the building works under items (i) to (iv) below in accordance with the plans approved by the Building Authority.
  - (i) Structure(s) erected on and over the yard at the rear of the premises; and
  - (ii) Structure(s) erected on the flat roof at 1/F; and
  - (iii) Structure(s) erected on and over the flat roof at the front on 2/F; and
  - (iv) Structure(s) erected on and over the roof.

(The locations of the building works described above are shown hatched-black on the plan annexed hereto, for the purpose of identification only.)

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

2. You are required to commence the works ordered by me in paragraph 1 above within **30** days and complete such works within **60** days of the date of this order, all to the satisfaction of the Building Authority.

3. For the said building works in paragraph 1 above:

- (a) Items (i) to (iv) have been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance.

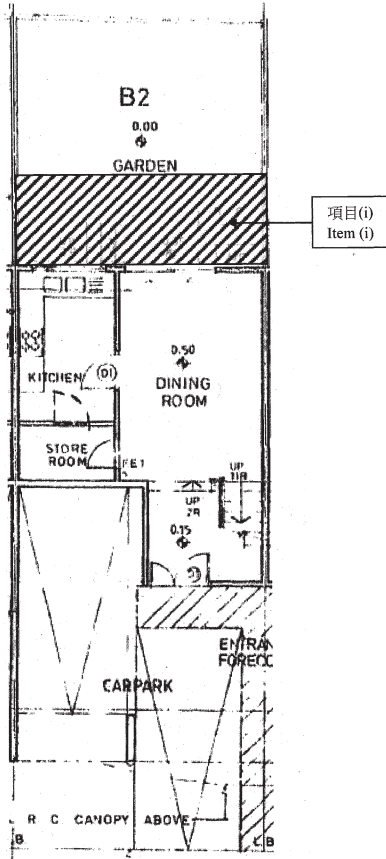

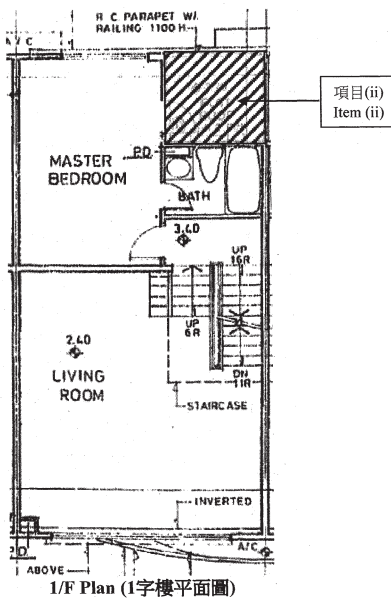

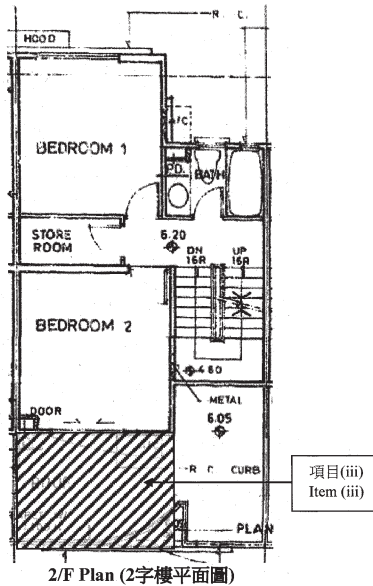

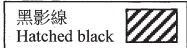

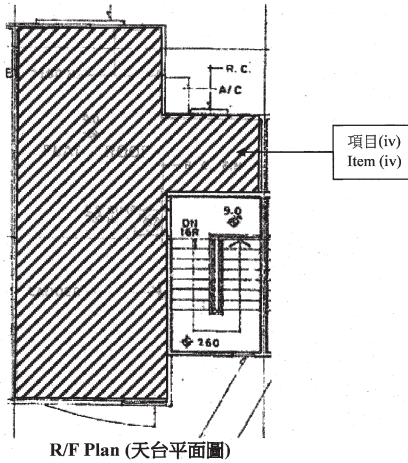
