PWP ITEM NO. 7705TH SHA TIN NEW TOWN, STAGE 2— TRUNK ROAD T4

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 60579757/GAZ/100 to 60579757/GAZ/106 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of dual two-lane elevated carriageways of approximately 1.4 kilometres long connecting Shing Mun Tunnel Road and Tsing Sha Highway to the proposed at-grade carriageways fronting The Riverpark;
- (ii) construction of dual two-lane at-grade carriageways and underpasses of approximately 600 metres long between The Riverpark and Tsang Tai Uk;
- (iii) construction of a slip road of approximately 300 metres long near Tsang Tai Uk connecting Lion Rock Tunnel Road southbound and Sha Tin Road eastbound;
- (iv) construction of a slip road of approximately 80 metres long near The Riverpark connecting Lion Rock Tunnel Road northbound and the proposed at-grade carriageway northbound across the Shing Mun River Channel;
- (v) construction of an at-grade and an elevated footpath of approximately 50 metres long across the proposed underpass near Sha Tin Tau Village;
- (vi) construction of an elevated cycle track and an elevated footpath of approximately 100 metres long across the Shing Mun River Channel;
- (vii) construction of an elevated cycle track and an elevated footpath with lift and staircase across Lion Rock Tunnel Road fronting The Riverpark;
- (viii) construction of an elevated footpath with lifts and staircases across Che Kung Miu Road;
 - (ix) construction of at-grade cycle tracks, central medians and amenity areas;
 - (x) modification of a section of the elevated carriageway of Shing Mun Tunnel Road eastbound near Chung Ling Lane of approximately 200 metres long to provide extra space for improved merging of traffic;
- (xi) modification and realignment of a section of Tung Lo Wan Hill Road, Chung Ling Road, Chung Ling Lane, Tai Po Road—Tai Wai, Shing Chuen Road, Shing Wan Road, Man Lam Road and Man Lai Road;
- (xii) widening of a section of Sha Tin Road of approximately 150 metres long from a dual twolane carriageway to a dual four-lane carriageway;
- (xiii) permanent closure and conversion of sections of the existing at-grade carriageways into at-grade footpaths, at-grade cycle track, central medians and amenity areas;
- (xiv) permanent closure and conversion of sections of the existing at-grade footpaths into at-grade carriageways, underpasses, at-grade cycle tracks, central median and amenity areas:
- (xv) permanent closure and conversion of a section of the existing elevated footpath into elevated carriageway;
- (xvi) permanent closure and conversion of sections of the existing at-grade cycle tracks into at-grade carriageways, at-grade footpaths and amenity areas;

- (xvii) permanent closure and conversion of sections of the existing central medians into at-grade carriageways;
- (xviii) permanent closure and conversion of sections of the existing amenity areas into at-grade carriageways, at-grade footpaths and at-grade cycle tracks;
- (xix) permanent closure and demolition of sections of the existing elevated carriageway, at-grade footpaths, at-grade cycle tracks and staircase;
- (xx) permanent closure and demolition of the existing pedestrian subway across Lion Rock Tunnel Road fronting The Riverpark;
- (xxi) permanent closure and demolition of the existing pedestrian subways across Che Kung Miu Road and Lion Rock Tunnel Road near MTR Che Kung Temple Station;
- (xxii) temporary closure and reconstruction of sections of the existing at-grade carriageways, elevated carriageways, at-grade footpaths, at-grade cycle tracks, central medians and amenity areas; and
- (xxiii) ancillary works including geotechnical, drainage, sewerage, water, utilities, lighting, landscaping, electrical and mechanical works, construction/reconstruction/demolition of noise barriers, construction of retaining walls and pedestrian crossings, slope improvement; and installation of street furniture and traffic aids.
