

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

ROAD WORKS UNDER PWP ITEM NO. B810CL  
SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING  
DEVELOPMENTS AT LONG BIN, YUEN LONG

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians/traffic islands, amenity areas and cycle tracks within the limit of works area as shown on Plans Nos. 261044/GZ/001 and 261044/GZ/002 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 8145 published on 20 December 2019 and 27 December 2019. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 17 February 2024 to 16 February 2025, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians/traffic islands, amenity areas and cycle tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a *cul-de-sac* at Castle Peak Road—Ping Shan, a single two-lane carriageway connecting Ma Fung Ling Road to Long Tin Road, a lay-by at Ma Fung Ling Road, a public transport interchange, three footbridges, and footpaths, amenity areas and cycle tracks along Long Tin Road, as well as other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, central medians/traffic islands, amenity areas and cycle tracks on 2 February 2024.

Any person having a compensatable interest under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
