ADVANCE SITE FORMATION AND ENGINEERING INFRASTRUCTURE WORKS AT  
KWU TUNG NORTH NEW DEVELOPMENT AREA AND  
FANLING NORTH NEW DEVELOPMENT AREA (ROAD WORKS)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways, elevated carriageways, at grade footpaths/accesses, elevated footpath/accesses, cycle tracks, amenity areas, central reserves/refuge islands and open spaces within the limit of works area as shown on Plans Nos. 60335576/GZ1/100 to 114 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 60335576/GZ1/100A, 60335576/GZ1/LEGEND, 60335576/GZ1/102A, 60335576/GZ1/103A, 60335576/GZ1/104A, 60335576/GZ1/105A, 60335576/GZ1/108A to 60335576/GZ1/113A and 60335576/GZ1/115 ('the Amendment Plans') and described in the amendment scheme annexed thereto, and as modified by Modification Plan No. 60335576/GZ1/108B ('the Modification Plan') and described in the modification annexed thereto. The Plans and scheme were referred to in G.N. 10021 published on 31 December 2015 and 8 January 2016. The Amendment Plans and amendment scheme were referred to in G.N. 6487 published on 18 November 2016 and 25 November 2016. The Modification Plan was referred to in G.N. 9204 published on 14 December 2018 and 21 December 2018. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 27 December 2021 to 26 December 2022, all public or private rights in, upon, under or over the sections of the existing at grade carriageways, elevated carriageways, at grade footpaths/accesses, elevated footpath/accesses, cycle tracks, amenity areas, central reserves/refuge islands and open spaces to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure is to facilitate the site formation works in the Kwu Tung North and Fanling North New Development Area, construction of the Fanling Bypass (Eastern Section) and associated engineering infrastructure works.

A copy of the order, the Plans, the Amendment Plans and the Modification Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected at grade carriageways, elevated carriageways, at grade footpaths/accesses, elevated footpath/accesses, cycle tracks, amenity areas, central reserves/refuge islands and open spaces on 17 December 2021.

Personal Information Collection Statement
