Late tenders and Tenders not deposited in the Specified Tender Box will not be accepted.

In case Tropical Cyclone Warning Signal No. 8 or above or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force for any duration between 9.00 a.m. and 12.00 noon (Hong Kong time) on 26 January 2022, the latest date and time before which Tenders are to be deposited at the Specified Tender Box will be extended to 12.00 noon (Hong Kong time) on the following working day on which no Tropical Cyclone Warning Signal No. 8 or above or a Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government is/are in force for any duration between 9.00 a.m. and 12.00 noon (Hong Kong time).

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.
