

**L.N. 234 of 2022**

**Shipping and Port Control (Amendment) (No. 2)  
Regulation 2022**

(Made by the Chief Executive in Council under section 80 of the Shipping and Port Control Ordinance (Cap. 313))

**1. Shipping and Port Control Regulations amended**

The Shipping and Port Control Regulations (Cap. 313 sub. leg. A) are amended as set out in sections 2 and 3.

**2. Regulation 23B amended (additional supplementary provisions on entry into restricted areas, etc.)**

(1) After regulation 23B(3D)—

**Add**

“(3E) Except with the permission of the Director—

- (a) a vessel which has a height exceeding that specified in paragraph 36(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Cross Bay Bridge Area No. 1 specified in paragraph 36(b) of that Schedule;
- (b) a vessel which has a height exceeding that specified in paragraph 37(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Cross Bay Bridge Area No. 2 specified in paragraph 37(b) of that Schedule;

- (c) a vessel which has a height exceeding that specified in paragraph 38(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Cross Bay Bridge Area No. 3 specified in paragraph 38(b) of that Schedule; or
  - (d) a vessel which has a height exceeding that specified in paragraph 39(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Cross Bay Bridge Area No. 4 specified in paragraph 39(b) of that Schedule.
- (3F) Except with the permission of the Director—
- (a) a vessel which has a height exceeding that specified in paragraph 40(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Interchange Area No. 1 specified in paragraph 40(b) of that Schedule;
  - (b) a vessel which has a height exceeding that specified in paragraph 41(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Interchange Area No. 2 specified in paragraph 41(b) of that Schedule; or
  - (c) a vessel which has a height exceeding that specified in paragraph 42(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Interchange Area No. 3 specified in paragraph 42(b) of that Schedule.

- (3G) Except with the permission of the Director—
- (a) a vessel which has a height exceeding that specified in paragraph 43(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Southern Bridge Area No. 1 specified in paragraph 43(b) of that Schedule; or
  - (b) a vessel which has a height exceeding that specified in paragraph 44(a) of the Fifth Schedule must not enter or pass through the Tseung Kwan O Southern Bridge Area No. 2 specified in paragraph 44(b) of that Schedule.”.

### **Explanatory Note**

This Regulation amends the Shipping and Port Control Regulations (Cap. 313 sub. leg. A)—

- (a) to specify the geographical co-ordinates defining—
  - (i) the Tseung Kwan O Cross Bay Bridge Area No. 1;
  - (ii) the Tseung Kwan O Cross Bay Bridge Area No. 2;
  - (iii) the Tseung Kwan O Cross Bay Bridge Area No. 3;
  - (iv) the Tseung Kwan O Cross Bay Bridge Area No. 4;
  - (v) the Tseung Kwan O Interchange Area No. 1;
  - (vi) the Tseung Kwan O Interchange Area No. 2;
  - (vii) the Tseung Kwan O Interchange Area No. 3;
  - (viii) the Tseung Kwan O Southern Bridge Area No. 1; and
  - (ix) the Tseung Kwan O Southern Bridge Area No. 2; and
- (b) to prohibit vessels exceeding certain heights from, except with the permission of the Director of Marine, entering or passing through the areas mentioned in subparagraph (a).
