NIM WAN ROAD (SOUTH)

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 245706/GZ/001 to 245706/GZ/006 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a single two-lane carriageway (tentatively named as 'Nim Wan Road (South)'), footpaths and amenity areas of approximately 2.4 kilometres long, connecting the existing road junction of Yung Long Road and Nim Wan Road to the road junction at the entrance of the existing T•PARK;
- (ii) reconstruction of a section of Nim Wan Road;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways;
- (iv) permanent closure and conversion of a section of the existing access road into carriageway, footpath and amenity area;
- (v) permanent closure of a section of the existing access road;
- (vi) permanent closure and conversion of a section of the existing verge into slope;
- (vii) demolition and conversion of sections of the existing slopes into carriageways, footpaths, verge and amenity areas;
- (viii) demolition and reconstruction of sections of the existing slopes;
- (ix) temporary closure and reconstruction of sections of the existing carriageways and footpaths, and a section of the existing verge;
- (x) temporary closure of sections of the existing carriageways, footpaths and verge; and
- (xi) ancillary works including site formation, geotechnical, landscaping, water, drainage, utilities diversion, street lighting and electrical and mechanical works, installation of traffic aids and street furniture, and construction of retaining walls and slopes.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection.
