ROAD WORKS UNDER PWP ITEM NO. 7873TH BOARDWALK UNDERNEATH ISLAND EASTERN CORRIDOR

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under sections 17(1)(a) and 17(1)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently the existing amenity area, motorcycle parking spaces and a section of the existing footpath: to close temporarily sections of the existing open spaces, pier, footpaths, carriageways and run-in/run-out; to reclaim the Government foreshore and/or sea-bed; and to affect/ temporarily reclaim the Government foreshore and/or sea-bed within the limit of works area as shown on Plan Nos. 91640/D/GAZ/0001 to 91640/D/GAZ/0005 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 7629 published on 31 December 2020 and 8 January 2021. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 29 December 2021, all public or private rights in, upon, under or over the existing amenity area, motorcycle parking spaces and a section of the existing footpath to be permanently closed, shall be extinguished; from 29 December 2021 to 28 December 2022, all public or private rights in, upon, under or over the sections of the existing open spaces, pier, footpaths, carriageways and run-in/run-out to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period; as from 29 December 2021, all public or private rights in, upon, under or over the Government foreshore and/or sea-bed to be reclaimed, shall be extinguished; and from 29 December 2021 to 28 December 2022, all public or private rights in, upon, under or over the Government foreshore and/or sea-bed to be affected/temporarily reclaimed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of deck structures, lift and staircase, open space as well as pedestrian crossing; demolition of a portion of the screen wall and planter of the existing promenade at Provident Centre to create an opening connecting to the proposed deck structures; and other ancillary works.

The works to be carried out in association with this reclamation mainly involve construction of substructures and piled dolphins for the proposed deck structures, modification of the existing pier near Tong Shui Road, as well as demolition of the existing piled dolphins of Island Eastern Corridor and the existing pier structures near Healthy Street East.
