This tender is covered by the Agreement on Government Procurement of the World Trade Organization (WTO GPA). This notice also serves as a summary notice required under WTO GPA.

Open tendering is adopted. All interested contractors/service providers are invited to tender.

Forms of Tender and further particulars are obtainable during office hours (Mondays to Fridays, except public holidays) from the Reception Counter of Agriculture, Fisheries and Conservation Department (AFCD) at 5th Floor, Cheung Sha Wan Government Offices, 303 Cheung Sha Wan Road, Kowloon (Telephone No.: (852) 2362 6988). The tender documents may also be downloaded from the e-Tender Box (ETB) of the Procurement and Contract Management System (PCMS) of the Government Logistics Department. For paper-based tendering, tenders in FIVE COPIES must be submitted in two separate envelopes (one on Technical Proposal and one on Fee Proposal), sealed and clearly marked with the tender reference, the subject of the tender and the tender closing date on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman of the Tender Opening Committee, Government Logistics Department and deposited in the Government Logistics Department Tender Box situated at the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon (Hong Kong time) on 16 February 2024 (Friday). Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

For electronic tendering, transmission of a tender through the ETB shall be successfully completed in accordance with the requirement of the ETB before the Tender Closing Time. Late tenders will not be accepted. If Tropical Cyclone Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the Tender Closing Date, the closing time will be postponed to 12.00 noon (Hong Kong time) on the first working day after the Tropical Cyclone Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the Tender Closing Date, the Government will announce extension of the Tender Closing Time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
