## PWP ITEM NO. B811CL (PART) SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING DEVELOPMENTS AT TUEN MUN CENTRAL— CONSTRUCTION OF PUBLIC ROAD ADJOINING TUEN HING ROAD, TUEN MUN

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. B811CL-GZ06 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a carriageway adjoining Tuen Hing Road;
- (ii) construction of footpaths, village track, pedestrian crossings, traffic islands, vehicular accesses and amenity areas;
- (iii) permanent closure and conversion of sections of the existing carriageways into footpaths and traffic islands;
- (iv) permanent closure and conversion of sections of the existing footpath into carriageway;
- (v) permanent closure and conversion of sections of the existing village road into carriageway, footpaths, amenity area and slope;
- (vi) permanent closure and conversion of sections of the existing village tracks into carriageway, footpaths and amenity area;
- (vii) permanent closure and demolition of sections of the existing carriageway, village road and village tracks:
- (viii) temporary closure and reconstruction of a section of the existing carriageway and sections of the existing footpath;
- (ix) temporary closure and modification of sections of the existing village track;
- (x) temporary closure of sections of the existing carriageways, footpaths, village roads and village tracks; and
- (xi) ancillary works including site formation, geotechnical, landscaping, drainage, sewerage, water, utilities, street lighting, retaining structure construction, slope construction and stabilization, as well as electrical and mechanical works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 22nd day of February 2022.
