The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest tender or the tender with the highest overall score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer. Details of the award of the contract will be published on the FHB's website mentioned above.

- Remarks:
- (i) For paper-based tendering, tenders must be submitted in two separate envelopes (one on Technical Proposal and one on Price Proposal), sealed and clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman of the Tender Opening Committee, Government Logistics Department and deposited in the Government Logistics Department Tender Box situated at the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the tender closing time.
 - (ii) For electronic tendering, transmission of the tender through the e-Tender Box shall be successfully completed in accordance with the requirements of the e-Tender Box before the tender closing time.
 - (iii) Late tenders or tenders not submitted in accordance with any one of the submission methods specified in (i) and (ii) above will not be accepted.
 - (iv) If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the Tender Closing Date, the closing time will be postponed to 12.00 noon (Hong Kong time) on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force.
 - (v) In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the Tender Closing Date, the Government will announce extension of the Tender Closing Time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
