

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING DEVELOPMENTS AT PIK WAN ROAD, YAU TONG (ROAD WORKS)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, pedestrian crossings and central reserves/refuge islands within the limit of works area as shown on Plan No. B812CL-GZ01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8451 published on 9 November 2018 and 16 November 2018. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 11 January 2022 to 10 January 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, pedestrian crossings and central reserves/refuge islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a pedestrian walkway system comprising footpaths, footbridges, lifts and lift towers with associated staircases, to connect Pik Wan Road, Ko Chiu Road and Lei Yue Mun Road, construction of a pedestrian walkway system comprising footpaths, a footbridge, lifts and a lift tower with associated staircase, to connect Ko Chiu Road and Lei Yue Mun Road, widening of Ko Chiu Path and a section of Ko Chiu Road near Lei Yue Mun Road Playground, road junction improvement works at the junctions of (a) Pik Wan Road and O King Road, (b) Pik Wan Road and Ko Chiu Road, and (c) Cha Kwo Ling Road and Ko Chiu Road, and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, pedestrian crossings and central reserves/refuge islands on 31 December 2021.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—

- (1) By post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);
