TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. 9AD111/GZP/001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 9374 published on 15 December 2017 and 22 December 2017. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 4 March 2023 to 1 September 2023, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of escalators and staircases to connect San Ha Street and Cape Collinson Road, construction of footpaths to connect the proposed escalators and staircases to Cape Collinson Road and the proposed columbarium, widening of a section of Cape Collinson Road, widening of a section of the existing footpath of San Ha Street, and other ancillary works.
