

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. HY/2023/07—Pedestrian Walkway System between Hing Shing Road and Tai Wo Hau Road and Provision of Covers on Walkways near Hong Kong Eye Hospital, Tuen Mun Hospital and Tang Shiu Kin Hospital**. The works include:—

- (a) Demolition of existing staircase connecting Hing Shing Road and Tai Wo Hau Road;
- (b) Construction of a covered two-way escalator and staircase with stair-lift connecting Hing Shing Road and Tai Wo Hau Road;
- (c) Construction of retaining wall and reprovisioning of affected structures and facilities near Buddhist Sin Tak College and Kwai Hong Court;
- (d) Slope works at Hing Shing Road Playground;
- (e) Construction of walkway covers near Hong Kong Eye Hospital, Tuen Mun Hospital and Tang Shiu Kin Hospital respectively and;
- (f) Associated civil works, geotechnical works, electrical and mechanical works, modification works for the existing walkways, roads and drainage works, lighting works and landscaping works.

The works are scheduled to commence in third quarter of 2023 and will take about 30 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box, located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 31 March 2023 (tender closing date). Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
