

L.N. 18 of 2022

Fixed Penalty (Smoking Offences) (Amendment) Regulation 2022

(Made by the Secretary for Food and Health under section 16 of the
Fixed Penalty (Smoking Offences) Ordinance (Cap. 600))

1. Commencement

This Regulation comes into operation on 30 April 2022.

2. Fixed Penalty (Smoking Offences) Regulation amended

The Fixed Penalty (Smoking Offences) Regulation (Cap. 600 sub. leg. A) is amended as set out in section 3.
