TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and amenity areas within the limit of works area as shown on Plan No. CDEKAT0014 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 6455 published on 11 November 2022 and 18 November 2022. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 3 March 2024 to 2 March 2025, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of dropped kerbs, the conversion of sections of the existing carriageways, footpaths and amenity areas into open space and other ancillary works.
