

CORRIGENDUM

With reference to Government Notice No. 293 in Gazette No. 2 Vol. 26 published on 14 January 2022 and Gazette No. 3 Vol. 26 published on 21 January 2022, it is hereby notified that the amendments are as follows:—

The following paragraphs of the tender documents should be amended to read as follows:—

1. Clause 10.4.1 of Part 2—Terms of Tender:—

The Tenderer bidding for Contract (A) shall propose a fleet of not less than 22 vessels, all as specified in Clause 6 of Sub-Part A of the Service Specifications for provision of the Services. All such vessels and other vehicles and equipment (if any) to be deployed must be listed out in Schedule 6 and subject to inspection by the Government. The number of vessels proposed in Schedule 6 shall not be less than the minimum number as stated above, and their specifications shall comply with the requirements specified in Sub-Part A of the Service Specifications, failing which the Tenderer's Tender for the Contract shall not be considered further. All such vessels, and other vehicles and equipment to be deployed must be issued with valid licences required by all applicable laws, and be clearly listed in Schedule 6.

2. Clause 10.4.2 of Part 2—Terms of Tender:—

The Tenderer bidding for Contract (B) shall propose a fleet of not less than 20 vessels, all as specified in Clause 6 of Sub-Part B of the Service Specifications for provision of the Services. All such vessels and other vehicles and equipment (if any) to be deployed must be listed out in Schedule 6 and subject to inspection by the Government. The number of vessels proposed in Schedule 6 shall not be less than the minimum number as stated above and their specifications shall comply with the requirements specified in Sub-Part B of the Service Specifications, failing which the Tenderer's Tender for the Contract shall not be considered further. All such vessels, and other vehicles and equipment to be deployed must be issued with valid licences required by all applicable laws, and be clearly listed in Schedule 6.

3. Clause 10.4.3 of Part 2—Terms of Tender:—

The Tenderer bidding for Contract (C) shall propose a fleet of not less than 6 vessels, all as specified in Clauses 6 and 7 of Sub-Part C1 of the Service Specifications for provision of the Services. All such vessels to be deployed must be listed out in Schedule 6 and subject to inspection by the Government. The number of vessels proposed in Schedule 6 shall not be less than the minimum number as stated above, and their specifications shall comply with the requirements specified in Sub-Part C1 of the Service Specifications, failing which the Tenderer's Tender for the Contract shall not be considered further. All such vessels to be deployed must be issued with valid licences required by all applicable laws, and be clearly listed in Schedule 6.

4. Clause 12 of Part 3—General Conditions of Contract:—

12.1 Upon request from time to time by the Government, the Contractor shall provide to the Government a list of the names, posts, staff identity card numbers, addresses and telephone numbers of all Contractor's employees, agents, sub-contractors and those employees and agents of the aforementioned sub-contractors (collectively 'Relevant Personnel') who may at any time require admission on behalf of the Contractor to any premises occupied by the Government for the purposes of the Contract if so required by the Government Representative, and in that event such list shall specify the capacities in which those persons are employed by or connected with the Contractor and shall contain such other particulars as the Government Representative may reasonably require.

12.2 The Contractor shall ensure that while any of the Relevant Personnel is on the Government's premises they will conform to the Government's normal codes of staff and security practice.

12.2A The Contractor shall require all Relevant Personnel, save for those exempted, to present vaccination record of at least the first dose of COVID-19 vaccine prior to their entry into indoor government premises which are their places of work, or for work-related purposes (including for meetings and for fulfillment of duties). The number of vaccine

doses required may be revised by prior written notice from the Government to the Contractor in the light of the development of COVID-19 epidemic situation.

12.2B Exemption from the requirement to present vaccination record will be granted to (a) those who are medically unfit for COVID-19 vaccination as supported by a valid medical certificate; and (b) pregnant staff with prior exemption to be granted by the Government on a case-by-case basis. The exempted categories of Relevant Personnel mentioned in this Clause may be revised by prior written notice from the Government to the Contractor.

12.2C For the purpose of Clauses 12.2A and 12.2B, the Contractor shall comply with the entry requirement of Government premises, implementation approaches, requirement on the vaccination record and other relevant documentations to be presented, consequence of non-compliance, maintenance and updating of the register of vaccination status, and all other necessary requirements as determined by the Government by prior written notice from the Government to the Contractor.

12.2D The Contractor shall ensure that the Relevant Personnel will have given consent to the Contractor to pass the personal data in relation to Clauses 12.2A and 12.2B above to authorised persons of the Government for the purposes of the provisions of this Clause 12 and other provisions of the Contract.

5. Clause 3.1(vi) of Part 4–Special Conditions of Contract (A) and Contract (B):—
Compile statistical reports based on (ii), (iii) and (iv) above.
6. Paragraph 4 of Annex E–Marking Scheme and Assessment Criteria For Provision of Marine Cleansing Services:—

Tenders for the Relevant Contract which have passed Stages I and II assessment will be evaluated according to the Assessment Criteria and Marking Guidelines as detailed in the Appendix 1 and Appendix 2 to this Annex. The maximum total technical marks are 100 and are divided into nine criteria for Contract (A) and Contract (B) and seven criteria for Contract (C). For Assessment Criteria (1), (2) and (3), passing marks of 4, 3 and 2 are set for Contract (A) and Contract (B) and 5, 4 and 4 are set for Contract (C) respectively, which are 20% of the maximum mark of the respective Assessment Criteria. Tenders that do not attain any of the above said passing marks for Assessment Criterion (1), (2) or (3) will not be considered further.
