

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. ED/2021/01, Elevated Landscaped Pedestrian Deck near MTR Kwun Tong Station (Public Works Programme Item No. 206TB)**. The works mainly comprise:—

- (1) construction of a covered elevated landscaped pedestrian deck of about 120 metres in total length;
- (2) carrying out associated slopes, walkways, drainage, landscaping works and other ancillary works; and
- (3) implementation of environmental mitigation measures for the proposed works.

The works are scheduled to commence in the first half of 2022 and will take about 42 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 8 April 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 8 April 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 8 April 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated below are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least one construction contract involving Roads and Drainage works with an adjusted contract sum of not less than HK\$75 million, in or outside Hong Kong, within the past ten years counted from the original date set for the close of tender. The adjusted contract sum shall be the original contract sum at the time of the contract award adjusted to current price as stipulated in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas on the tenderer's qualification are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 16 March 2022 to Chief Engineer/E4, East Division 4, East Development Office, Civil Engineering and Development Department, 8th Floor, South Tower, West Kowloon Government Offices, 11 Hoi Ting Road, Yau Ma Tei, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly

Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
