

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DE/2021/08—Term Contract for Overhaul, Maintenance, Testing and Plant Engineering Works of Electrical and Mechanical Installations at Various Sewage Treatment Facilities and Pumping Stations on Lantau and Outlying Islands**. The works comprise the overhaul, maintenance, testing and plant engineering works of electrical and mechanical installations at various sewage treatment works and pumping stations on Lantau and Outlying Islands for thirty-six (36) months. The works are scheduled to commence in July 2022 for completion in June 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 8 April 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 8 April 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 8 April 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Category of 'Electrical and Mechanical Installation for Sewage Treatment and Screening Plant', *except those 'on probation' or 'with restrictions to sewage (including stormwater) pumping stations only' or 'with restrictions to screening plant and small package treatment plant only'*, or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder/one of the members being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Category of 'Electrical and Mechanical Installation for Sewage Treatment and Screening Plant', *except those 'on probation' or 'with restrictions to sewage (including stormwater) pumping stations only' or 'with restrictions to screening plant and small package treatment plant only'*, who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Category of 'Electrical and Mechanical Installation for Sewage Treatment and Screening Plant' may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Friday, 25 March 2022 to Chief Engineer/Sewage Treatment 2, Sewage Treatment Division 2, Drainage Services Department at 2nd Floor, Administration Building, Stonecutters Island Sewage Treatment Works, Ngong Shung Road, Ngong Shuen Chau, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
