

ROAD TRAFFIC (TRAFFIC CONTROL) REGULATIONS (Chapter 374G)

RESTRICTED ZONES ON HIP WO STREET, HIU KWONG STREET AND
SAU NGA ROAD, KWUN TONG

In exercise of the powers vested in me under regulation 14(1)(b) of the Road Traffic (Traffic Control) Regulations, Chapter 374G, I hereby direct that with effect from 10.00 a.m. on 10 March 2022, the following road sections in Kwun Tong will be designated as restricted zones:—

From 7.00 a.m. to 7.00 p.m. daily

- (a) the western kerbside of Hip Wo Street from a point about 40 metres north of its junction with Hiu Kwong Street to a point about 90 metres north of the same junction;

From 7.00 a.m. to 7.00 p.m. daily (except General Holidays)

- (b) the western kerbside of Hip Wo Street from a point about 55 metres north of its southern junction with Yuet Wah Street to a point about 105 metres north of the same junction;

From 8.00 a.m. to 10.00 a.m. and 5.00 p.m. to 7.00 p.m. daily

- (c) the northern kerbside of Sau Nga Road from a point about 25 metres east of its junction with Hip Wo Street to a point about 100 metres east of the same junction;

24 hours daily

- (d) the western kerbside of Hip Wo Street from a point about 10 metres north of its southern junction with Yuet Wah Street to a point about 55 metres north of the same junction;

- (e) the section of Hip Wo Street from a point about 35 metres south of its junction with Hiu Kwong Street to a point about 40 metres north of the same junction;

- (f) the section of Hip Wo Street from a point about 30 metres south of its junction with Sau Nga Road to a point about 35 metres north of the same junction;

- (g) the section of Hiu Kwong Street from its junction with Hip Wo Street to a point about 35 metres east of the same junction; and

- (h) the section of Sau Nga Road from its junction with Hip Wo Street to a point about 25 metres east of the same junction.

Within the restricted zones of items (a), (b) and (c) above, drivers of all motor vehicles, except franchised buses, taxis and those with permits issued by the Commissioner for Transport, will be prohibited from:—

- (a) picking up or setting down passengers; or
(b) loading or unloading goods.

Within the restricted zones of items (d), (e), (f), (g) and (h) above, drivers of all motor vehicles, except franchised buses and those with permits issued by the Commissioner for Transport, will be prohibited from:—

- (a) picking up or setting down passengers; or
(b) loading or unloading goods.

The extent of the restricted zones will be indicated by appropriate traffic signs and road markings.

At the same time, the existing restricted zones on the above road sections will be rescinded.
