## MARINE PARKS ORDINANCE (Chapter 476)

(Section 8(1))

In accordance with section 7 of the Marine Parks Ordinance (the Ordinance), the Country and Marine Parks Authority has prepared a draft map (Plan No. MP/NL) for the proposed North Lantau Marine Park.

The proposed Marine Park is located in the North Lantau waters of the Hong Kong Special Administrative Region and covers a sea area of about 2 400 hectares.

Copies of the draft map, together with other information relating to the proposed marine park, are available for inspection by the public free of charge at the following Government Offices for a period of sixty days from the date of publication of this Notice during the hours when these offices are normally open to the public.

Such written statement shall set out:—

- (a) the nature of and reasons for the objection; and
- (b) if the objection would be removed by an alteration to the draft map, any alteration proposed.
